Please note, Beck **does not offer bulk billing**, so there will be out of pocket / gap expenses. All patients (except DVA or self-managed NDIS) are required to pay the full fee at the time of their appointment, and they will receive any benefits from Medicare following their appointment. Patients with private health insurance may be eligible for a rebate, depending on level of cover.
